

Terms of Service

DataCC will provide Internet Service on its network and computing systems and also provide installation of necessary equipment (cable, antennas and standard computer equipment) to subscribers subject to your compliance with the Terms and Conditions below. Please read these Terms and Conditions carefully before accessing the DataCC Service. By accessing the Service, you acknowledge that you have read and understand these Terms and Conditions and that you agree to be bound by the terms and conditions below. If you do not wish to be bound by these terms and conditions, you should not access or use the service.

Use of the DataCC Service and the Internet

Subscriber shall pay for the full retail cost of, or the repair or replacement of any lost, stolen, unreturned, damaged, sold, transferred, leased encumbered or assigned equipment or part thereof, together with any costs incurred by DataCC in obtaining or attempting to obtain possession of any such equipment. On expiration or termination of this Agreement, Subscriber authorizes DataCC to retrieve from Subscriber's premises equipment for appropriate disposition, that is owned by DataCC.
